**MEETING OPENED**

Mr. LaPray called the meeting of the Board of Directors of the Orange County Drainage District to order at 10:00 a.m. Mr. Hood led the Invocation and the Pledge of Allegiance.

**CONSIDERATION AND APPROVAL OF AMENDMENT TO THE BUDGET FOR FISCAL YEAR 2019-2020 FOR THE PURPOSE OF BUDGETING ADDITIONAL EXPENSES ASSOCIATED WITH THE PURCHASE OF FIXED ASSETS, SURVEY SOFTWARE AND LICENSE FEES, AND THE REFLECTION OF ADDITIONAL BUDGET ADJUSTMENTS**

Mr. Covington made a motion to approve the amendment to the budget for fiscal year 2019-2020 for the purpose of budgeting additional expenses associated with the purchase of fixed assets, survey software and license fees, and the reflection of additional budget adjustments. Mr. Fuselier seconded the motion. Motion carried 4-0.

**CONSIDERATION AND ACCEPTANCE OF THE CERTIFICATION OF CURRENT AND DELINQUENT TAX ROLLS BY THE ORANGE COUNTY TAX ASSESSOR-COLLECTOR**

Mr. Covington made a motion to accept the Certification of Current and Delinquent Tax Rolls by the Orange County Tax Assessor-Collector. Mr. Fuselier seconded the motion. Motion carried 4-0.

**CONSIDERATION AND APPROVAL OF PESTICIDE APPLICATOR RECERTIFICATION TRAINING FOR NEAL FORD ON NOVEMBER 7, 2019 IN BEAUMONT, TEXAS**

Mr. Arrington made a motion to approve the Pesticide Applicator Recertification Training for Neal Ford on November 7, 2019 in Beaumont, Texas. Mr. Fuselier seconded the motion. Motion carried 4-0.

Mr. Fuselier made a motion to approve the renewal of the annual membership with South East Texas Regional Planning Commission. Mr. Arrington seconded the motion. Motion carried 4-0.

**BOARD GOES INTO EXECUTIVE SESSION**


