**CONSIDERATION AND POSSIBLE ACTION REGARDING THE RENEWAL OF TML MULTISTATE IEBP HEALTH INSURANCE COVERAGE FOR PRE-65 RETIREES FOR CALENDAR YEAR 2020**

Mr. Covington made a motion to approve the renewal of TML MultiState IEBP health insurance coverage (Gold Plan) and dental insurance coverage for Pre-65 Retirees for calendar year 2020. Mr. LaPray seconded the motion. Motion carried 5-0.

**DISCUSSION AND APPROVAL OF A SUBDIVISION PLAT INTO LOT NUMBERS 1 – 8 OF CARDINAL HEIGHTS ADDITION**

Mr. Arrington made a motion to table consideration of a subdivision Plat into Lot Numbers 1 – 8 of Cardinal Heights Addition. Mr. LaPray seconded the motion. Motion carried 5-0.
